# 1.0 Academic Advocacy

#### 1.1. Definition of Academic Advocacy

Academic Advocacy in the Faculty of Community Services means to support the implementation of an integral academic, professional development, or career development experience for students that will be useful after their years here.

#### 1.2. Progress of Academic Advocacy

The Faculty of Community Services Society in Winter, Fall 2020 and January 2021 advocated to the Dean's Office to send emails to the Dean's List recipients, and receive a special certificate and letter signed by the Dean to reconize their achievement. These were the only times in our faculty's history these were given out. It succeeded thanks to the student society.

# 2.1. Principals

The Faculty of Community Services Society (FCSS) will focus on creating a well balanced academic achievement environment for all students that encourages appropriate technical skill building, advocate to implement mandatory real workforce experiences, and celebration of achievements.

#### 2.3. Importance

The Faculty of Community Services Society (FCSS) recognizes the importance of Acdemic Advocacy in-terms of enhancing the student experience in correlation to Toronto Metropolitan University's 2030 Academic Plan. The FCSS must ensure all advocacy campaigns are related to a majority of the programs in the Faculty of Community Services, and be focused on Faculty-level problems (not program-program course changes). For program course changes the advocacy must come from the Course Union of a program, NOT the Student Society.

# 3.0 Goals of Academic Advocacy

#### 3.1. Deans List Letters

Ensuring that every year there are congratulations emails, and digital copies of Dean's List letters delivered to undergraduate students in the Faculty of Community Services.

#### 3.2. Paid Placements and Co-ops

Ensuring that each year we build upon the proposal, and work with key stakeholders until the advocacy, and project is complete. This process takes 4-5 years to complete.

#### 3.3. Mandatory Co-op or Placement Requirement in each program

Ensuring that each year we build upon the proposal, and work with key stakeholders until the advocacy, and project is complete. This process takes 2-3 years to complete.

#### 3.4. Dean's List Lunch

Ensuring that each year with a levy we host in collaboration with the Dean's Office a Dean's List Lunch for the undergraduate students who successfully obtained the Dean's ist Award.
